



Courtesy Visit to Kericho County Officials - Governor

A courtesy visit was made to the County's Minister of Gender, Hon. Beatrice Kaptich, and the Governor, Hon. Dr. Mutai, to discuss project results and explore collaborative opportunities to advance gender equality. This visit aimed to expand Uraia Trust's ecosystem for quality gender-responsive civic education and engagement. This is in partnership with UN Women and Global Affairs Canada.

Kericho County Women Leaders Advocacy and Implementation of Gender-Responsive Policies Training

This follow-up activity aimed to reinforce previous project results by boosting the capacity of women leaders in the county. Women members of the county assembly identified issues affecting them

and wrote position papers to the county head for action. Training covered communication, lobbying, and gender-responsive features, especially in preparation for the county's financial year. Capacity building for women leaders and review of the status of the County's Gender Equality and Women Empowerment (GEWE) Bill.

Regional Roundtable forums on the Demand Side of Service delivery

Uraia convened three regional roundtable forums in the Frontier Counties Development Council, Mt Kenya and Aberdare's Region Economic Bloc, and the Lake Region Economic Bloc targeting actors in the demand side of service delivery. The roundtable forums were part of a qualitative study supported by the World Bank as part of the Kenya Accountable Devolution Program and will play a crucial role in shaping the World Bank's service delivery programs to strengthen demand side institutions.

CARE – Women Voice and Leadership Programme (WVL) Project


Women's Rights **Organizations** (WROs) WVL project under the implementing continue their interventions during the No-Cost Extension Period ending 31st July 2024 to influence gender-responsive programming and amplify the voices of women and girls. Interventions have focused on capacity building for women and institutions.

A notable initiative by Uraia Trust, sponsored CARE International Kenya. **CARE** by Canada, and Global Affairs Canada, is a series of capacity-building sessions by Eco Network Africa Fund (ENAF) under the Democracy Trust Fund. On 10th and 17th July 2024, ENAF hosted over 100 women for training to enhance their understanding of the electoral cycle and political party positioning, facilitated in part by the Office of the Registrar of Political Parties. Additionally, prospective women leaders were informed about existing factors and emerging legal issues, such as the new Independent Electoral and Boundaries Commission Act and its implications for women's political participation in preparation for the upcoming general elections in Kenya.

Uraia conducted draft recommendations to different duty bearers to help ensure the spaces for women participation in leadership and decision making processes are expanded in Wajir and Homabay Counties.

The team hosted peer-to-peer a on male engagement forum, focusing engagement, and brought together community gatekeepers from all wards in Embu County. This forum facilitated candid discussions among men about the role of women in leadership, particularly within the with active participation from county, community gender champions.

Elders and morans committed to gender equality and expanded space for women's political participation,



involving women in peace committees through deliberations on negotiated democracy and women's leadership.

Homa Bay Review and Drafting of SGBV Control and Management Bill

Recommendations were made to the County Attorney General, and the bill is set to be presented to the Homa Bay County Assembly. This effort addresses SGBV, a significant barrier to women's political and leadership pursuits, thus expanding the landscape for women's participation.





Homa Bay Gender Champions Engagement on Gender-Responsive Budgeting

Gender champions committed to a roadmap for gender-responsive budgeting at the county level, aiming to expand spaces for women's participation in county financial and budgeting processes.

Kisii County CSOs and WRO Forum on Implementation of the 2/3 Gender Rule

A forum was held to discuss the implementation of the 2/3 gender rule in Kisii County, aiming to ensure compliance and expand women's political participation.

Wajir County Technical Working Group on Gender – meeting.

The group discussed contextual gender issues and analyzed the county's gender policies and legislations, providing recommendations to influence the county's operationalization and promote gender equality.

Strengthened youth capacity and empowered them to participate effectively and meaningfully in public finance matters and influence governance decisions as well as advocate for transparency and equity in resource distribution. This was done through capacity building a pool of 20 youth budget champions, from Kisumu and Nairobi Counties, to enhance their knowledge on participatory budgeting, public expenditure tracking, monitoring public service delivery and evidence-based advocacy.

To this end the Nairobi youths TOTs analyzed the Nairobi budget Estimates 2024/2025 alongside Nairobi CIDP 2023-2027, CFSP 2024 and the ADP 2024/2025 and gave their submissions during the public participation in their respective sub counties-Mathare & Kibra.

Regional Refresher Trainings for civic educators

In June 2024, Uraia conducted eight regional refresher sessions for its civic educators in preparation for the start of the 2024 initial civic education phase. These sessions enhanced the knowledge transfer skills of Uraia's civic educators on contemporary civic education issues and the reviewed civic education curriculum and training manuals.

The 2024 Civic Education Phase

Uraia commenced its initial phase of civic education nationwide during the quarter, through its extensive network of more than 350 civic educators in all the 47 counties. The primary objective of this phase is to pilot the revised Uraia civic education curriculum and training manuals, as well as to support ongoing participation in planning and budgeting processes.

Celebrating Legendary Civic Educators

On the 30th of June, twenty-five individuals who have shown exceptional dedication to promoting civic education were recognized and honored in a special fete graced by the Uraia civic education county coordinators. The honoree's included Uraia civic educators who have served for more than a decade, as well as civic educators who integrated and championed specific thematic areas such as gender advocacy, children's and minority riahts in their civic education work. Additionally, both current and former members of the secretariat responsible for managing civic education programs were recognized for their distinguished service in managing civic education work over the years.

Celebrating Joseph Kamonye Manje – A legendary Civic Educator

Joseph Kamonye Manje, a seasoned civic educator with Uraia trust based in Ruiru Constituency, Kiambu County, envisions a future where citizens are fully engaged in governance processes. At seventy-three years, Joseph takes pride in his long-standing contribution to civic education in Kenya and enjoys every opportunity to interact with communities and help them understand the importance of using their voices and agency in decision making processes.

Joseph's passion for civic education began in the 1970s after he completed his studies at the University of Nairobi. Along with his colleagues, he was at the forefront in challenging the poor leadership practices in Kenya at that time. Joseph recalls how they undertook covert efforts to mobilize the public against the ruling class in a repressive political environment that stifled dissent. Their initial attempt at civic education involved publishing a series of information leaflets dubbed 'pambana' and distributing them secretly at night to raise awareness among the masses. Despite the challenges in obtaining resources for printing and distribution, Joseph and his group were committed to organizing cells of champions who used guided civic education messaging to enlighten citizen movements within the university and across Kenya.

In the 1980s, amid growing calls for change, particularly the push to repeal section 2A of the constitution that established Kenya as a single-party state, Joseph Kamonye Manje peers joined Muungano his Wazalendo wa Kenya (Union of Patriotic Kenyans), also known as Mwakenya. Mwakenya was an outlawed underground movement known for creating publications that protested governance inefficiencies by the political regime at that time. The movement's members advocated for expanding democratic space in Kenya through public lectures and distributing leaflets such as Mpatanishi and Mzalendo. These materials provided civic education by explaining the group's views on the country's political issues; an approach that the ruling class branded as 'radical'. Joseph's involvement in the movement was a significant aspect of his commitment to promoting education and democratic values. He was later arrested and detained for possessing leaflets, which were considered these seditious by the authorities.

After serving a five-year term in Kibos Prison, Joseph Kamonye Manje returned home and resumed his teaching career before retiring in 1995. Following his retirement, he joined Release of Political Prisoners in Kenya (RPP), a 'solidarity organization' supporting individuals arrested, detained, or harassed for their political activities in Kenya. During this time, RPP members engaged with the National Civic Education Program (NCEP 1 & 2), which aimed to foster a mature political culture by making citizens more aware of their rights and responsibilities and encouraging their active participation in expanding democracy in Kenya. Joseph broadened his civic education efforts by becoming a community mobilizer and governance trainer for the NCEP traveling theatre. He was actively involved in the push for constitutional reforms and the demand for a new constitution, a dream that he proudly witnessed come to life with the promulgation of the Constitution of Kenya on August 27, 2010.

In 2015, Joseph Kamonye Manje was seconded to join the national network of civic educators through CRECO and was stationed in his home constituency of Ruiru in Kiambu County. After completing an induction training, he expressed his satisfaction with the structured and well-guided approach to civic education that had been adopted by Uraia through the civic education curriculum and the accompanying training manuals. Since his involvement, he has successfully trained over thirty groups and reached more than six thousand individuals within his constituency through the comprehensive six-week program and other opportunistic meetings. He is especially encouraged by the positive impact this initiative has had on service delivery, which has strengthened his commitment to expanding his outreach efforts. With the advent of devolution and a more decentralized governance model, Joseph finds renewed inspiration in the closer proximity governance to the people. He believes this shift has made it easier for citizens to exercise their power and influence decisions affecting their governance. Joseph remains optimistic about the potential for continued engagement the enhancement of democratic processes within his community.
